**ELECTRICITY DISTRIBUTION BYLAW (CONSOLIDATED)**

A BYLAW OF THE TOWN OF CARDSTON IN THE PROVINCE OF ALBERTA TO PROVIDE FOR DISTRIBUTION OF ELECTRICITY AND IS TO BE CALLED THE ELECTRICITY DISTRIBUTION BYLAW.

**Whereas**, pursuant to the *Municipal Government Act*, RSA 2000, M26.1 as amended; and pursuant to the *Electric Utilities Act* RSA 2000, c. E-35, as amended, and any regulations pertaining thereto, and that these Acts and Regulation grant the Municipality certain rights and powers concerning the ownership of electrical distribution systems and their uses.

**And Whereas**, it is expedient to make provisions for the management and control of the Electrical System of the Town of Cardston, and to provide rules and regulations regarding the use of electricity and the provision of electrical distribution services and to establish a Distribution Tariff, distribution access services of electrical rates and charges, and a Regulated Rate Tariff;

Now therefore, the Council of the Town of Cardston, duly assembled, enacts as follows:

- 1) The Purpose of this Bylaw is to provide for the distribution of electricity within the Municipality of the Town of Cardston.
