Town of Cardston Regulated Rate Option Tariff

Residential

This rate schedule is for the provision of electricity services by ENMAX Energy Corporation on behalf of the Town of Cardston in accordance with the Regulated Rate Option Regulation (AR 262/2005) and the Electric Utilities Act, S.A. 2003, c.E-5.1.

Eligibility

1. This rate applies to “rate classification customers” as defined by the Regulated Rate Option Regulation (AR 262/2005).
2. This rate applies to all residential customers eligible for CRD100 distribution service pursuant to the Town of Cardston Distribution Tariff.

Energy Charge:	Changes Monthly \$/kWh
Administration Charge:	0.2562 \$/day
Service and Facilities Charge:	Per Distribution Tariff
System Usage Charge:	Per Distribution Tariff
Balancing Pool Rider:	Per Distribution Tariff

Local Access Fee

The LAF is a charge determined by Town Council that applies to all electric sites in the Town of Cardston.

Terms and Conditions

All services provided under this rate will be billed monthly and are subject to the Town of Cardston Terms and Conditions of Service for the Regulated rate Option Tariff.

Town of Cardston Regulated Rate Option Tariff

Small Commercial

This rate schedule is for the provision of electricity services by ENMAX Energy Corporation on behalf of the Town of Cardston in accordance with the Regulated Rate Option Regulation (AR 262/2005) and the Electric Utilities Act, S.A. 2003, c.E-5.1.

Eligibility

1. Commercial customers are eligible for this rate if a reasonable forecast of the customer's annual consumption of electric energy at a Site is less than 250 MWh.
2. This rate applies to all commercial customers eligible for CRD200 distribution service pursuant to the Town of Cardston Distribution Tariff.

Service and Facilities Charge: (first 2 kVA of Demand)	Per Distribution Tariff
Service and Facilities Charge: (additional kVA of Demand)	Per Distribution Tariff
System Usage Charge: (first 200 kWh per kVA of Demand)	Per Distribution Tariff
Balancing Pool Rider:	Per Distribution Tariff

Medium Commercial

This rate schedule is for the provision of electricity services by ENMAX Energy Corporation on behalf of the Town of Cardston in accordance with the Regulated Rate Option Regulation (AR 262/2005) and the Electric Utilities Act, S.A. 2003, c.E-5.1.

Eligibility

1. Commercial customers are eligible for this rate if a reasonable forecast of the customer's annual consumption of electric energy at a Site is less than 250 MWh.
2. This rate applies to all commercial customers eligible for CRD400 distribution service pursuant to the Town of Cardston Distribution Tariff.

Service and Facilities Charge (kW): (first 50 kVA of Demand)	Per Distribution Tariff
Service and Facilities Charge (kW): (next 450 kVA of Demand)	Per Distribution Tariff
Service and Facilities Charge: (additional kVA of Demand)	Per Distribution Tariff
System Usage Charge:	Per Distribution Tariff
Balancing Pool Rider:	Per Distribution Tariff
